#### WHAT WILL I DO ON THE BOARD?

#### Role

Board of Directors is responsible for providing direction for the company and setting the Strategic Plan for the business of the company. Directors also monitor the company's operations as outlined in the Constitution, By-laws and obligations within all relevant Acts.

### **Duties and Responsibilities**

Some of the duties and responsibilities for directors include;

#### **Care and Diligence**

This duty requires a director to;

- become familiar with the fundamentals of the business and operations of the company;
- keep informed and make appropriate inquiries about the company's activities;
- generally, guide and monitor the company's activities;
- maintain familiarity with the financial status of the company;
- have a reasonably informed opinion of the company's financial capacity and solvency.

#### **Good Faith**

This duty requires a director to act honestly and to the best of their ability in the interests of the company.

#### Not to improperly use position

This duty requires directors to not use their position to gain an advantage for themselves or others.

#### Not to improperly use information

This duty requires directors to not use the information they gain in the course of their director duties to gain an advantage for themselves or others.

#### Insolvent trading

Directors have a duty to ensure that the company does not trade whilst insolvent or where they suspect it might be insolvent.

#### **Financial information**

Directors should take reasonable steps to ensure that the company complies with its obligations in the Corporations Act 2001 related to the keeping of financial records and financial reporting.

#### **Time Commitment**

- All directors are expected to participate in Corporate Governance sessions. These sessions are organised for all directors after the AGM. Usually require a 1-2 day commitment.
- The Board has a monthly meeting, currently held on the fourth Tuesday of the month at 6pm.
- Perusal and awareness of financial documents, gaming reports, management report and minutes of previous meetings prior to the Board Meeting.
- Perusal and awareness prior to the meeting of any other documents to be tabled or discussed at Board Meetings.
- Additional Board Meetings are called only when needed, usually for a specific decision-making purpose.
- Represent the company in the community and with company's stakeholders.

#### Role

The Sailing Committee is to;

Conduct club racing and regattas in accordance with the sailing calendar.

#### **Training and Coaching**

Provide input to management in relation to engagement of external coaches and senior training and coaching sailing personnel.

#### **Sailing Assets Management**

Identify and plan for sailing asset replacement, and procurement of additional assets.

#### Sailing Budget

In consultation with management, develop a complete Annual Sailing Budget (including capital / staff / operation costs);

Make recommendation to the board regarding Annual Sailing Membership fees for all sailing membership classes including any discounts if applicable.

#### **Sailing Policies and Procedures**

Ensure all sailing related policies and procedures, are up-to-date, relevant, and communicated to Members.

#### **Sailing Members Representation**

Ensure the views, ideas, concerns or suggestions of Sailing Members are taken into consideration when making decisions.

#### **Time Commitment**

The Sailing Committee has a monthly meeting, currently held on the second Tuesday of the month at 5:30pm.
